3. For what purpose do we process your data?

At EV Services we process the information you provide to us in order to:

- Respond to inquiries or requests for information.
- Manage the commercial or contractual relationship.

4. What is the legitimacy for the processing of your data?

The legal bases for the processing of your data are:

- The consent of the data subject (contact or subscription form).
- The performance of a contract or the application of pre-contractual measures.
- Compliance with legal obligations.

5. How long will we keep your data?

Your personal data will be kept for the time strictly necessary to comply with the purpose for which they were collected, as well as to attend to possible legal responsibilities.



6. To whom will your data be communicated?

No data will be transferred to third parties, except under legal obligation or when necessary for the provision of the requested service (for example, technology providers with whom we have signed confidentiality and data processing contracts).

7. What are your rights?

You have the right to:

- Access your personal data.
- Request the rectification of inaccurate data.
- Request their deletion when they are no longer needed.
- Object to the processing of your data.
- Request the restriction of processing.
- Request the portability of your data.
